

CREDIT COUNSELING REQUIREMENT

The new bankruptcy reform act requires you to complete a credit counseling session with a credit counseling agency approved by the United States Trustee before you can file a chapter 13 case. You are not eligible to file a bankruptcy unless you receive an individual or group briefing from an approved nonprofit budget and counseling agency. Therefore, I strongly recommend you complete the credit counseling the day you receive this questionnaire.

The credit counseling session must outline your opportunities for available credit counseling and assist you in performing a related budget analysis. Credit counseling is available in person, by phone or on the internet. A list of approved credit counseling agencies appears below.
